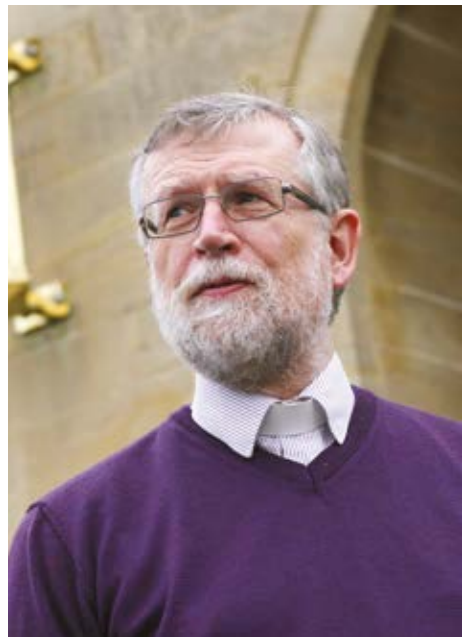

## Legal protection

If you're ever involved in a dispute related to your occupation, our insurance could meet the costs. For just £25 (plus Insurance Premium Tax) a year, this policy covers legal protection for proceedings under the Clergy Discipline Measure 2003. It also provides legal expenses cover in relation to any disputes, inquiries or grievances if you hold Common Tenure under the Ecclesiastical Offices (Terms of Service) Measure 2009.



### What is covered?

Up to £250,000 to cover costs and expenses to:

Help provide a formal written response to a complaint made against you under the Clergy Discipline Measure 2003 (limited to £1,000 + VAT).

Represent you at a hearing before a disciplinary tribunal or the Vicar General's Court.

Appeal against a finding and/or penalty following the hearing.

Represent you in a dispute concerning your terms and conditions of service.
