Privacy notice

Under certain circumstances, by law you also have the right to: (i) request erasure of your personal data and information where there is no good reason for us continuing to process it or you have exercised a right to object to the processing of your personal data and information; (ii) request the restriction of processing of your personal data and information; and (iii) request the transfer of your personal data and information to another third party. Please write to the Data Protection Officer whose details are set out above. We will take all reasonable steps to confirm your identity before responding to your request. If consent of processing your personal data is withdrawn then we may be unable to process your entry for the purposes of the Competition. Where you are providing us with information about a person other than yourself such as the data for anyone featuring in your entry, you agree to notify them of our use of their personal data and obtain their consent to our use of any special categories of personal data such as religious beliefs.
